NRC: Inspection Procedures

In the case of vehicles placed in operation on or before March 7, 1989, §393.11 requires that vehicles meet either the lighting requirements of part 393 or Federal Motor Vehicle Safety Standards (developed and issued by the National Highway Traffic Safety Administration) (FMVSS) No. 108 in effect at the time of manufacture.
