## **New Edition Of Judicial College Guidelines Published ...**

The guidelines do not bring any significant changes to the level of damages for personal injury. Instead all brackets have been increased to reflect inflation (an increase of 4.8% since the last edition of the JC Guidelines). A whiplash injury lasting 3 months will now be awarded between £1,200 to £2,150 (up from £1,160 to £2,050).
